Laurence Boisson de Chazurien is an Associate Professor of Law at the University of Montreal and Director of the Centre for International Dispute Settlement (MIDA). She is a member of the Global High Level Panel on Water and Peace and an Member of the Institute of International Law. She is an advisor to various international organizations, governments and law firms in the field of dispute settlement, she has served as arbitrator in international disputes and has pleaded before the ICJ and other dispute settlement fora.

André Bonquet is a Professor of Law at the University of Antwerp. He completed his studies in Law in Antwerp (1980-1983) and in European Law in Ghent (1983-1986). He practised commercial and maritime law in Belgium (Antwerp and Brussels) from 1986 to 1990. In 1990, he joined the European Commission, where he initially dealt with nuclear supplies at the European Supply Agency and later in 2000 he joined the Commission's Legal Service, where he practised in the area of competition law (cartels and mergers), then in agriculture and fisheries, and most recently in the area of external relations and law of the sea.

Rolf Einar Fife is a Norwegian ambassador to the European Union since 2019. Prior to that he served between 2012 and 2014 as the Director General of Legal Affairs of the Norwegian Ministry of Foreign Affairs and between 2014 and 2016 as Norway's ambassador to France. He was Chair of the Council of Europe Committee of Legal Experts on Public International Law (2008-2010). He headed negotiations on maritime delimitation as well as petroleum and fisheries cooperation with the Russian Federation (Barents Sea and Arctic Ocean matter 2007 and 2010) and other neighbouring States. He headed the Norwegian team before the Commission on the Limits of the Continental Shelf. A graduate of the University of Oslo, he worked at the Polar Department, Ministry of Justice (1980-1983) and since 1983 at the Ministry of Foreign Affairs with postings in the Middle East (1988-1990) and at the Norwegian Mission to the UN, New York (1990-1992). At the Ministry of Foreign Affairs, he headed various units in the Legal Department prior to becoming its head in January 2019. He was a
